Acknowledgment of Risk and Release Agreement

1. In return for being allowed to enter the VFT premises and enter onto VFT's laser simulated shooting range ("the Facility"), and to observe and/or participate in laser simulated shooting and other activities at VFT, I expressly agree to accept and assume any and all risks existing on VFT premises and at the Facility, and in entering onto the Facility, using the Facility and equipment, and engaging in or observing laser simulated shooting and other activities at the Facility or otherwise occurring on VFT premises. I agree to abide by all rules and Facility rules of VFT. I consent to administration of first aid and other medical treatment in the event of injury or illness at VFT.

2. **I HEREBY ACKNOWLEDGE** that I have voluntarily applied to enter onto and to engage in or to observe laser simulated shooting and other activities at VFT, including the Facility. I further acknowledge and understand that "laser simulated shooting and other activities" includes any and all activities of all kinds whatsoever in which I can engage in or observe while on VFT premises, whether sponsored by VFT or any other person or entity.

3. **I ACKNOWLEDGE AND UNDERSTAND** that laser simulated shooting and other activities involve both known and unknown risks, which could result in damage or destruction to my property or property of others, and physical or emotional injury, including partial or total loss of eyesight or hearing, paralysis or death to myself or others. I understand that such risks cannot be eliminated without compromising the essential qualities of laser simulated shooting activities, and so I accept those risks and the consequences in return for being allowed to enter VFT premises, enter onto the Facility, and participate or observe laser simulated shooting and other activities at VFT.

4. **I FURTHER ACKNOWLEDGE AND UNDERSTAND** that the nature and condition of the Facility and the VFT premises is such that both known and unanticipated risks and hazards exist, which create or contribute to both known and unanticipated risks inherent in entering VFT premises, in entering onto the Facility, and in engaging in or observing laser simulated shooting or any other activities of any kind whatsoever while on VFT premises. I understand that such risks and hazards cannot be eliminated without compromising the essential qualities the Facility and VFT equipment, premises and environment. I acknowledge and understand that neither VFT nor any of its owners, managers, members, shareholders, officers, directors, partners, agents, representatives or employees has a duty to undertake first aid or rescue operations or procedures in the event any such property damage or physical or emotional injury occurs, and that any such operations or procedures may result in compounded or increased damages or injuries.

5. **I FURTHER ACKNOWLEDGE AND UNDERSTAND** that neither VFT nor any of its respective owners, managers, members, shareholders, officers, directors, partners, agents, representatives or employees makes any representation or warranty as to the design, manufacture, maintenance, condition or fitness for any particular purpose of any of the premises or equipment at VFT, including, but not limited to: the Facility, firearm laser simulation, eye/hearing protection if necessary, and first aid supplies.

6. **I FURTHER ACKNOWLEDGE AND UNDERSTAND** that some laser simulated equipment may be considered as a "firearm" under the definition provided by State law, and because of this, should my criminal background prohibit my use or possession of a firearm for any reason, I will not use the laser simulated equipment provided at the Facility.

7. **I FURTHER AGREE** to assume all responsibility and liability for any negligent, reckless or criminal act or omission to act all of my guests at VFT. I understand that "Guests" include any person who is not a member of VFT who enters VFT premises, enters onto the Facility, or uses the Facility, or who engages in or observes laser simulated shooting and other activities at VFT as a result of my express or implied invitation, permission or consent. I agree that I will ensure that each of my guests reads and signs an "Acknowledgement of Risk and Release."

8. **I AGREE NOT TO SUE, AND I RELEASE, AND FOREVER DISCHARGE** VFT, and its owners, managers, members, shareholders, officers, directors, partners, agents, representatives, volunteers, and employees, successors and assigns, and the sponsors of any event at VFT and their affiliates, and each of their respective subsidiaries, managers, members, shareholders, officers, directors, partners, agents, representatives and employees (collectively, the "Releasees") for, from and against any and all present and future liabilities, obligations, damages, losses, claims, costs or expenses of any kind whatsoever that may be made by me, my family, estate, heirs, guardians, representatives or assigns for property damage, personal injury or death arising as a result of me or my guests entering VFT premises, entering onto the Facility, using the Facility or equipment, or engaging in or observing laser simulated shooting or other activities at the Facility, even if such claims result partially or wholly from any act or acts, even any negligent act or omission to act, including negligent or omitted first aid or rescue operations or procedures, by any of the Releasees. I understand and agree that none of the Releasees is responsible for any claim, if caused by his/her/its own negligence.

9. **I UNDERSTAND** that amateur or commercial still video, videography and other motion picture photography may occur during my presence on VFT premises or while using the Facility and that I may be incidentally included in such photography. Should I wish to be excluded from such photography, I understand that it is my responsibility to be aware of the photography activity and remove myself from the area or event being photographed. Absent such action on my part, I hereby grant VFT the right to use my photographic images in the promotion of VFT, or laser simulated shooting sports in general, in accordance with applicable law.

10. **I FURTHER ACKNOWLEDGE AND AGREE** that this Agreement is intended to be as broad and inclusive as permitted by applicable law and that if any provision or portion is held to be invalid, contrary to law, void or otherwise unenforceable, that such portion does not void any other part of this Agreement and that the remaining provisions or portions shall continue and remain in full legal force and effect.

11. **I FURTHER ACKNOWLEDGE AND AGREE** that it is my understanding and intent that this Agreement, and any signed written amendments or modifications to it, shall remain in full force and effect and shall be applicable to each and every occasion that I or any guest of mine enter onto VFT premises, enter onto the Facility, use the Facility or equipment or engage in or observe laser simulated shooting or other activities on VFT premises.

I HAVE CAREFULLY READ THIS AGREEMENT AND UNDERSTAND ITS CONTENTS. I ACKNOWLEDGE THAT NO OTHER INDUCEMENT, ASSURANCE OR GUARANTEE HAS BEEN MADE TO ME IN CONSIDERATION OF MY SIGNING THIS AGREEMENT, WHICH I SIGN VOLUNTARILY AND OF MY OWN FREE WILL. I FURTHER ACKNOWLEDGE AND AGREE THAT THIS AGREEMENT MAY BE AMENDED OR MODIFIED ONLY BY A WRITING SIGNED BY ME AND BY AN AUTHORIZED AGENT OF VFT.

Code of Conduct and Safety Rules

Though shooting is laser simulated, it is important that all shooters remember and follow the fundamental rules of safety:

Rule One: Only point your firearm at its intended target.

Rule Two: Keep your finger off the trigger until your sights are on the target.

Rule Three: Be sure of your target.

Rule Four: Do not point any laser equipment at or in the eye of any person.

Code of Conduct

This Code of Conduct and Safety Rules is established to promote the safety of all Facility users and our staff. Negligent or irresponsible behavior or commission of significant or intentional violations may result in the immediate removal of the violator from the VFT premises, as well as other potential penalties up to and including a permanent Facility ban or Membership forfeiture. VFT reserves the right to modify or change this Code of Conduct at any time, without prior notice.

1. No live ammunition or functioning firearms are allowed into VFT building. VFT provides all equipment for use in VFT laser simulated shooting and other activities.
2. Minors (under the age of 16) must be accompanied by a parent or legal guardian authorized to sign the Acknowledgement of Risk and Release and who must remain with the minor at all times on the Facility.
3. Shirt and shoes are required at all times while on VFT premises or while on the Facility.
4. Loitering on the VFT premises or in the adjacent parking lot is strictly prohibited.
5. No outside food or beverage is allowed on the VFT premises. No drugs, alcohol, or smoking of any kind is permitted on VFT premises.
6. If you observe any unsafe condition, report it to any VFT staff member immediately.
7. Any reports of theft, whether of VFT property or the personal property of others, will be investigated and, if necessary, prosecuted to the fullest extent of the law.
8. Shooters are required to act responsibly and courteously at ALL times while at VFT premises. Any bullying or harassment of any person is strictly prohibited.
9. Any person who intentionally damages property or is discourteous, verbally or physically aggressive to, other patrons or staff will be immediately removed from the Facility and

asked to leave the VFT premises. No refunds or prizes earned will be provided in such cases.

10. Members and all of member's family members and guests will show respect for and obey all applicable laws, rules, and regulations while on VFT premises.
11. All Members will welcome new Members and patrons with an attitude of sportsmanship and friendship and will strive to provide a safe and welcoming environment, to avoid harm, and respect the privacy of others.
12. Appropriate and clean attire is required. This includes, but is not limited to, any type of dress with exposed underwear or skin which is inappropriate for a family environment.
13. There shall be no tolerance for behavior, activities, or apparel promoting gangs or hate groups within the VFT premises or at any sponsored activity, event, competition or training if held outside of the VFT premises.
14. Filming or photography is expressly prohibited while on the VFT premises.
15. VFT personnel reserve the right to deny entry to the VFT premises at their discretion or to deny entry for scheduled Facility use times if an individual appears to be impaired.
16. All persons are required to view the instructional video prior to Facility use.
17. Persons who have reservations at VFT must arrive 15 minutes prior to the scheduled reservation time, as laser simulated shooting begins at the time of scheduled appointment.
18. No outside salespersons attempting to solicit VFT patrons are permitted on the VFT premises.
